ST. KITTS AND NEVIS **POLICE CERTIFICATE REQUEST**

To obtain a Police Certificate from the Federation of St. Kitts and Nevis the following information is required:

NATIONALS	
•	An <u>Original</u> or <u>Certified</u> Copy of your Birth Certificate or a copy of your Canadian passport or new CARICOM ePassport bio-data page.
•	If submitting a birth certificate, it must be accompanied by a valid and clear picture ID.
_ •	A full set of finger prints.
•	A St. Kitts and Nevis EC\$10 Stamp (Must be Cash, Equivalent to CAD \$5).
_ ·	A CAD\$86.00 money order made payable to the <u>Consulate General of St. Kitts</u> <u>and Nevis</u> for processing and courier fees to St. Kitts and Nevis. If a third party is acting on your behalf a notarized letter from a power of attorney is required. A letter from a power of attorney is NOT required if the Consulate General of St. Kitts and Nevis in Toronto is acting on your behalf.
NON-NATIONALS	
•	Non- nationals must present a notarized certificate of citizenship in addition to all the documentation required by nationals as stated above.
•	A copy of the Immigration Document (Work or Study Permit, Visitors Visa) when you first Entered the Federation of St. Kitts and Nevis.
•	A copy of the Exit Stamp from your passport when you left the Federation of St. Kitts and Nevis.
