## CITIZENSHIP BY MARRIAGE

- 1. All Applicants must be married for three (3) years or more.
- 2. Completed Application form.
- ☐ 3. Spouse's Birth Certificate.
- ☐ 4. Applicant's Birth Certificate.
- 5. Marriage Certificate.
- 6. A Divorce Decree/ or Death Certificate if either spouse was married before.
- 7. An Original Police Certificate from the place(s) the Spouse has been residing for the last six (6) months.
  - 8. An Original or certified copy of Certificate of Spouse (where applicable).
- 9. Money order for:
  - CAD\$ 250 or EC\$ 500 if married before 1983.
  - CAD\$ 500 or EC\$ 1000 if married after 1983.
- 10. Two (2) Passport size photographs (The size of the photographs is 1.77" x 1.38" (45mm x 35mm)
